The Low Income Premium Program (LIPP) is designed to help persons who qualify for NMMIP coverage remain on Pool coverage by offering a reduced premium.

Income does not determine pool eligibility. You must meet the eligibility requirements on the NMMIP application to be eligible for coverage.

To find out if you should apply for LIPP, find your household size and the corresponding yearly income amount in the table below. If:

- You are currently enrolled or apply and meet all eligibility requirements for the Pool **and**
- You or someone in your family will pay your monthly premium and
- Your total household income is within the amounts listed in the table below you may qualify for a reduced premium and should complete this application.

Household Income Information and Verification

NOTE: For the 2024 verification process, the New Mexico Medical Insurance Pool will be using the Modified Adjusted Gross Income (MAGI) method to determine your eligibility for the Low Income Premium Program (LIPP). MAGI is adjusted gross income (AGI) plus these, if any: untaxed foreign income, non-taxable Social Security benefits, and tax-exempt interest. Follow these basic rules when including members of your household:

- Include your spouse if you're legally married
- If you plan to claim someone as a tax dependent for the year you want coverage, do include them on your application
- If you won't claim them as a tax dependent, don't include them
- Include your spouse and tax dependents even if they don't need health coverage

Adjusted Gross Income (AGI) + Non-Taxable Social Security Benefits + Tax-Exempt Interest + Excluded Foreign Income = Modified Adjusted Gross Income (MAGI)

Adjusted Gross Income (AGI): As defined by the IRS, AGI is gross income minus adjustments to income This can be found on Line 11 of the 2022 1040 tax filing form

Non-Taxable Social Security Benefits: Social Security benefits not included in gross income This can be found on Line 6a of the 2022 1040 tax filing form

Tax-Exempt Interest: Interest income that is not subject to federal income tax

This can be found on Line 2a of the 2022 1040 tax filing form

Excluded Foreign Income: Foreign earned income excluded from taxation of individuals who live abroad

In addition,

- Attach a copy of the previous year's Federal Income Tax forms filed (include certification form if filed electronically) by each household member who had income, *except as excluded above*, and complete and sign the Federal Tax Form Affidavit (Affidavit A) portion of this application – AND/OR –
